Corporate/Active Membership.....\$250 *eligible individuals, partnerships, and corporations may become Active Members. Corporate members may list their affiliation. At meetings of members, each Active Member is entitled to cast two (2) votes.*

Associate/Individual Membership.....\$125 *any eligible individual may be admitted as an Associate member. Also open to any commercial establishment which is interested in the development of economic relations between France and the United States, but has no office in the U.S. At meetings of members, each Associate member is entitled to one (1) vote.*

Academic/Student Membership.....\$30 *eligible faculty or student of undergraduate or post-graduate studies may be admitted as an Academic member. At meetings of members, Academic members are non-voting members of the corporation.*
